Your email dated 30<sup>th</sup> February 2017 is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

Please supply the military service histories of the Land Rover 101FC vehicles 75FL87, 73FL09, 73FL27 & 73FL50 under the Freedom of Information Act

I can confirm that the Ministry of Defence (MOD) holds some information relevant to your request. Information is held for vehicles 75FL87, 73FL09 and 73FL27. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached.

Information is not held for vehicle 73FL50. You may wish to contact the Royal Logistic Corps Museum who may be able to assist your research. The contact details for the museum are below. You should be advised, however, that they may make a charge for their services.
