Thank you for your email of 27th October 2016 which I can confirm is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested information on the following vehicle:

"Armstrong MT500 general purpose motorcycle. Its military reg number was: 91KD74"

I can confirm that the Ministry of Defence holds information relevant to your request. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached.

Please note that the Information Commissioner will not investigate your case until the MOD internal review process has been completed.
