# REQUEST UNDER THE FREEDOM OF INFORMATION (SCOTLAND) ACT 2002 (FOISA)

Thank you for your request dated 8 July 2020 under the Freedom of Information (Scotland) Act 2002 (FOISA).

#### Your request

"I would like to make a freedom of information request for the next ten sets of minutes of meetings dated after the last one you sent me in foi 2020 00045872, relating to Bifab (Burntisland Fabrications)."

#### Response to your request

While our aim is to provide information whenever possible, in this instance we are unable to provide some of the information you have requested because of exceptions under section 30(b)(i) – free and frank provision of advice; section 30(b)(ii) – free and frank exchange of views; section 33(1)(b) – commercial interests; and section 38(1)(b) – personal data of a third party. The reasons why these exceptions apply are explained in the Annex A to this letter.

The information that we are able to provide is included in Annex B to this letter.

I note that you have made similar requests for minutes of meetings relating to BiFab under FOISA (FOI202000045872 and FOI202000058749) for which responses have been provided. However, I would like to highlight that, under Section 14(1) of FOISA, the Scottish Government does not have to comply with requests that are vexatious. Therefore, I must advise that, should you make any further requests that are similar in *scope* to your previous requests for information, the Scottish Government will be under no legal obligation to provide you with the information that you have requested.

The Scottish Government participates in and hosts a high volume of meetings relating to BiFab, with a variety of different stakeholders. Thus, a high volume of meetings fall under the scope of your request and it might be the case that some of

these meetings are not of interest to you. For further context, and as the information released to date will indicate, Scottish Government officials have met and will continue to meet with Ministers, developers, tier 1 suppliers, DF Barnes, Grant Thornton, MacRoberts, BiFab, and trade unions to discuss BiFab – not to mention a number of daily meetings at an official level.

If you wish to make further requests for minutes of meetings relating to BiFab, I would kindly suggest that you make your request more focussed to a particular meeting Doing so would allow Scottish Government officials to search for the specific minute in question, rather than conducting a wide ranging search for any minutes that might relate to BiFab.

## Your right to request a review

If you are unhappy with this response to your FOI request, you may ask us to carry out an internal review of the response, by writing to Kersti Berge, Director, Energy & Climate Change Division at <a href="mailto:kersti.berge@gov.scot">kersti.berge@gov.scot</a>. Your review request should explain why you are dissatisfied with this response, and should be made within 40 working days from the date when you received this letter. We will complete the review and tell you the result, within 20 working days from the date when we receive your review request.

Exemptions under Sections 30(b)(i) (free and frank provision of advice) and 30(b)(ii) (free and frank exchange of views) of FOISA apply to some of the information requested. These exemptions apply because disclosure would, or would be likely to, inhibit substantially the free and frank provision of advice and exchange of views for the purposes of deliberation.

Section 30(b)(i) recognises the need for Ministers and officials to receive advice within a private space before the Scottish Government reaches a settled public view. Similarly, Section 30(b)(ii) recognises the need for Ministers and officials to have a private space within which to discuss issues and options with external stakeholders before the Scottish Government reaches a settled public view. Disclosing certain aspects of the content of these discussions with Burntisland Fabrications Ltd (BiFab), DF Barnes, Grant Thornton, and our Enterprise Agencies would substantially inhibit such discussions in the future, because these stakeholders would be reluctant to provide their advice and views fully and frankly if they believe that those views are likely to be made public. This is a particular risk when discussions relate to a sensitive or controversial issue such as commercial negotiations.

These exemptions are subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is a public interest in disclosing information as part of open, transparent and accountable governance, and to inform public debate. However, there is a greater public interest in allowing Ministers and officials to have a private space within which to communicate with appropriate external stakeholders as part of the process of exploring and refining the Government's position on commercial or financial information, until the Government as a whole can adopt a decision that is sound and likely to be effective.

This private space is essential to enable all options to be properly considered, so that good decisions can be taken based on fully informed advice and evidence. Premature disclosure is likely to undermine the full and frank discussion of issues between the Scottish Government and these stakeholders, which in turn will undermine the quality of the decision making process, which would not be in the public interest.

An exemption under section 33(1)(b) (commercial interests) of FOISA applies to some of the information requested. This exemption applies because disclosure of this particular information would, or would be likely to, prejudice substantially the commercial interests of BiFab and DF Barnes. Disclosing this information would be likely to give BiFab's competitors an advantage in future similar tendering exercises, which would substantially prejudice the company's ability to submit competitive tenders and could significantly harm their commercial business.

This exemption is subject to the 'public interest test'. Therefore, taking account of all the circumstances of this case, we have considered if the public interest in disclosing

the information outweighs the public interest in applying the exemption. We have found that, on balance, the public interest lies in favour of upholding the exemption. We recognise that there is a public interest in disclosing information as part of open and transparent government, and to help account for the expenditure of public money. However, there is a greater public interest in protecting the commercial interests of companies that enter into contracts with the Scottish Government, thus ensuring that we are always able to obtain the best value for public money.

Exemptions under Section 38(1)(b) (personal data of a third party) of FOISA applies to some of the information requested. This exemption applies to the names of third parties referenced throughout the documents that have been requested. The Scottish Government has a policy of not disclosing the names of officials who are not Senior Civil Servants, therefore the names of some Scottish Government, Scottish Enterprise, and Highlands & Islands Enterprise officials have been redacted. The names of BiFab and DF Barnes employees who are not BiFab board members, and the names of our commercial advisors, have also been redacted to protect their privacy.

- FH interested to hear about EDF projects particularly NnG and the impact COVID
- Matthieu been developing renewables in Scotland for 10 years. Keen to do more in Scotland and very important to the company. Opened in an office in Edinburgh which houses 100+. Extensive portfolio across UK majority in Scotland. Majority of activity in onshore wind and of course NnG in offshore keen to do more and looking to bid into ScotWind. Plus solar PV and battery but not really in Scotland at the moment. Keen to work closely with supply chain and the local community proactively engaging with opportunities for the Scottish supply chain on NnG. Circumstances of COVID is challenging for all the company and isn't at the moment [Redacted], not furloughing anybody nor have any intension to do so. Looking to continue operations safely and following the guidelines, and in consultation with communities and contractors. Looking at new ways of working spoke to Mr Wheelhouse last week and welcome the engagement with SG Ministers and officials.
- Construction Burnwood East has stopped and NnG; but now slowly looking at ways to restart activity.
- FH value the relationship with EDF. Renewables will continue to be a key part of our industrial future. Especially in current climate in a green recovery. Pleased that Eyemouth has Operations & Maintenance and Dundee to be a catalyst to support wider supply chain. Encouraged that Saipem discussions are moving to conclusion.
- Seen as a country that operates safely and give the workforce confidence to return to work. Finding ways to engage the community and potential local politicians to inform of what is going to happen.
- Opportunity to showcase Scotland from end to end from development to community engagement
- Matthieu community engagement is key to us and will share the feedback with us. On supply chain, there are challenges to increase the local content. What we see that there a lot of SMEs that can provide services but difficult to find larger companies (Tier 1/2)

- Companies like [Redacted] have worked proactively but challenges to be competitive remain, as others out with Scotland. Companies need to work together collaboratively to make a greater offering.
- FH build on resilience to ensure supply chain is competitive and offer a product. Important area and we need to work together to improve. There will be more demand for renewable energy so there is a real opportunity.
- FH keen to meet face to face when we can.
- Matthieu planning on the approach Scotland takes and a strategy behind that, grid is key to ensure future development
- FH as part of COVID speaking to UK Government impressing on them to [Redacted].
- Matthieu recent Contracts for Difference (CfD) announcement on the reintroduction of onshore wind and solar and the consultation will prove fruitful.

## **Key Discussion Points:**

- Cabinet Secretary stressed the importance of delivering economic benefits to Scotland from the Seagreen project, essentially in these current times.
- Jim Smith (JS) commented on the [Redacted].
- JS referenced the [Redacted] of all [Redacted] following his meeting with [Redacted], in particular a thorough review of what [Redacted] could undertake. This highlighted that [Redacted] could be made to [Redacted] as this would limit risk but [Redacted] they were [Redacted] than the average [Redacted]. # **Key Discussion Points:**

- First Minister acknowledged the efforts [Redacted]had undertaken since [Redacted] financially and the wider benefits it could bring to Scotland.
- First Minister expressed her profound concern about all 114 jackets being fabricated in China and as a result a missed opportunity for Scotland's supply chain. If the decision remains it will bring enormous media attention to SSE and it would be very difficult for the government not to make comment.
- She continued by stressing the importance of delivering economic benefits to Scotland from the Seagreen project, especially in these current challenging times, referencing SSE's Greenprint document last week which highlights this theme.

- APD highlighted that supporting local supply chain will become more challenging in the future if costs continue to fall, with investment required in infrastructure to make the companies more competitive. [Redacted].

- Officials spoke to Martin Adam, the Managing Director of BiFab, in the afternoon of 1 June to discuss the Cabinet Secretary's request that it consider what, if any, [Redacted].
- Martin Adam referenced his wish for [Redacted] to the [Redacted] in [Redacted] of the [Redacted], to increase the [Redacted] of the [Redacted]. Whilst this would reduce the amount of time workers were required to work outdoors (where the risk of bad weather impacting productivity exists), it would [Redacted] to SSE as [Redacted] would be minimal. This proposal was, we understand, discussed at high level with SE around a year ago but not progressed at the time, due to the business' concern as to [Redacted].
- Officials were also advised by the Managing Director in the afternoon of 1
  June that the documents provided by [Redacted]late last week (which BiFab
  were asked to [Redacted] and [Redacted]if there was scope for [Redacted]
  have now gone through their first phase of review, and that these in fact
  [Redacted]. Some of [Redacted] such as an increase of the [Redacted] in
  areas the business is prepared to [Redacted].
- However, the drawings provided on 28 May from [Redacted]now require BiFab to provide [Redacted] within the [Redacted]. Martin Adam advises that the [Redacted], would need to be [Redacted].
- BiFab's local management team is discussing the [Redacted] to [Redacted] with DF Barnes tomorrow, and has requested [Redacted]be undertaken by the Canadians. Local management has a desire [Redacted], but state that DF Barnes is [Redacted] of [Redacted]. Martin Adam indicated that a call between BiFab and SG officials this week may help [Redacted]— but does acknowledge that any [Redacted] would not [Redacted] the [Redacted] between [Redacted]. The company does not expect to respond to [Redacted]until the end of this week noting that [Redacted] did not set an earlier deadline for a response.
- BiFab's [Redacted] as quoted to [Redacted] assumes that [Redacted] can be obtained at [Redacted]. However, given JV Driver's [Redacted] and [Redacted] subject to the relevant approvals, it could be the case that [Redacted]is asked to [Redacted]. To do so, the contract would need [Redacted] and thus, even if BiFab was to [Redacted] it would need to be [Redacted].
