### **APPENDIX 1**

### SUMMARY OF REASONS FOR APPROVAL

The Panel considered Mr Ashton to be a confident and capable person with a good history of public service. It was particularly noted by the Panel that Mr Ashton has sound commercial experience and is adept in dealing with budgets and these skills will inevitably add value to his role.

The Panel welcomed the Mr Ashton's stated aim of undertaking more community engagement, which was reflective of the Commissioner's approach in the pre-election period. The Panel believes that the Deputy's role would be considerably enhanced by increasing his understanding and appreciation of the diversity of the various communities which exist across the whole County. In particular the Panel considered that a greater awareness of the differences in the policing of the urban, as opposed to the rural, environment would bring a knowledge and understanding that would benefit both of these communities.

The Panel would also encourage the Deputy to develop a greater understanding of the role played by the Community Safety Partnerships within the policing of Cambridgeshire. This could only add further value to this role.
