Thank you for your information request, received on 20 August 2020

You requested the following information:

1. The number of missed bin collections in 2018, 2019 and 2020. Response:

- 2. How many extra bin lorries had to be sent out to pick up bins missed during their routine collections in 2018, 2019, 2020.
 - Response: No extra vehicles were used in the collection of missed bins. Crews deal with their own complaints the next day.
- 3. The additional costs to the council resulting from missed bin collections in 2018, 2019 and 2020. Response: They were collected the following day within the working hours so the only additional cost will be fuel costs, that is fuel cost for going out of their normal route which will be less than £10.
