You asked: Under the Freedom Of Information Act I would like to request the following data:

- The number of missed bin collections in 2018, 2019 and 2020

Answer:

2020 **449 End of August**

- How many extra bin lorries had to be sent out to pick up bins missed during their routine collections in 2018, 2019, 2020

Answer: Information not held when we receive a missed bin report we incorporate this into a round that's is passing the property.

- The additional costs to the council resulting from missed bin collections in 2018, 2019 and 2020

Answer: Information not held.
