Your email dated is considered to be a request for information under the Freedom of Information Act (FOIA) 2000. You requested the following information:

"a 1986 Land Rover 90 that was once owned by the MOD. The number of the vehicle is SALLDVAC7AA269400"

I can confirm that the Ministry of Defence (MOD) holds information relevant to your request. Unfortunately, following the closure of MERLIN it is only possible to retrieve information held on the archived version of the database, which is attached.

This information supplied to you continues to be protected by copyright. You are free to use it for your own purposes, including for private study and non-commercial research, and for any other purpose authorised by an exception in current copyright law. Documents (except photographs) can be also used in the UK without requiring permission for the purposes of news reporting. If you remain dissatisfied following an internal review, you may take your complaint to the Information Commissioner under the provisions of Section 50 of the Freedom of Information Act. Please note that the Information Commissioner will not investigate your case until the MOD internal
