FOI 3814-19 Modern Slavery Incidents

This workbook has been created at the request of the Information Access Team.

It contains the total number of recorded occurrences in relation to modern slavery incidents between the 01 June 2019 and 31 September 2019 (based on the entered date), broken down by month and type.

Important Notes:

- Results are extracted from a live crime information system, which is subject to change over time.
- The date an occurrence was recorded (the entered date) is used to determine if it falls within the specified period. The incident may have occurred in a different period.
