REQUEST UNDER THE FREEDOM OF INFORMATION (SCOTLAND) ACT 2002 (FOISA)

Thank you for your request dated 12 July 2022 under the Freedom of Information (Scotland) Act 2002 (FOISA).

Your request

You asked for information relating to the authority's current Multi-Functional Devices and printing/scanning services contract(s)

Response to your request

This is a formal notice under section 17(1) of FOISA that the Scottish Government (SG) does not hold the information you have requested. This is because we do not collect this information at a directorate level.
