REQUEST FOR INFORMATION: WEBSITE NAME CHANGES FROM MAFF TO DEFRA AND TO GOV.UK

Thank you for your request for information about the costs associated with website name changes from MAFF to Defra and in turn to GOV.UK, which we received on 9 May 2014. As you know, we have handled your request under the Freedom of Information Act 2000 (FOIA).

In summary, you asked:

- How much the change of name from MAFF (2001) to Defra (mid 2001) and now to GOV.UK - I realise it covers three 'titles' but perhaps the fiscal details could be found ?
- May I ask please, what is an "arm's length body" ?

I am very sorry that we did not reply to your enquiry sooner. From the wider context in your email, I presume that your enquiry relates specifically to Defra's website.

I can confirm that (as far as I can recall) there were no costs incurred in creating the Defra website when the department was formed, in June 2001, from MAFF and from the environmental protection and wildlife management functions of the then DOE. The editorial and technical work was done by Defra staff as part of their normal jobs.

I can also confirm that no costs were incurred in moving existing information from the Defra website onto the GOV.UK website. Again, the work was done by staff in Defra and in the Government Digital Service as part of their normal jobs.
