Your questions and my findings are as follows:-

1. I understand that you've been awarded funds from the National Productivity Investments Fund. Please could you provide me with all the bids that you submitted including any appendices and supporting documents submitted alongside the bids?

Please find below descriptions of the information requested, separated by the Local Authority the bids fall under. The information is attached to the covering email. Some information has been redacted and is detailed where in the table below. The exemptions applied are as follows:
