Request under the Freedom of Information Act 2000 (the "FOI Act")

We refer to your email of 19 October 2020 in which you requested information under the FOI Act from NHS Improvement. Since 1 April 2016, Monitor and the NHS Trust Development Authority have been operating as an integrated organisation known as NHS Improvement. For the purposes of this decision, NHS Improvement means Monitor and the TDA.

Your request

You made the following request:

"The Interim People Plan, which was published by NHS England and Improvement in June 2019, highlighted that a new National NHS People Board will be established to oversee progress against the People Plan. Please could you provide a list of all individuals currently appointed to the NHS National People Board, including their name and role on the board.

In addition, an article published by NHS England outlined that Marie Gabriel has been appointed as the new Chair of London's People Board: https://www.england.nhs.uk/london/2020/09/07/marie-gabriel-to-chair-new-nhs-london-people-

Please could you provide a list of the NHS Regional People Boards established/being established to date and the names of all individuals appointed to each board, including their role on the board.

If any of this information is already available in the public domain, please direct me to its location."

Decision

NHS Improvement holds the information you have requested and has decided to release some of the information it holds. We are withholding the names of non senior staff members under section 40(2) of the FOI Act.

Section 40(2) states that requested information is exempt from disclosure if the first or the second condition at section 40(3A)(a) of the FOI Act is satisfied. This is on the grounds that they amounts to personal data and the first condition under section 40(3A)(a) is satisfied, namely that disclosure would amount to a breach of the first data protection principle (personal data should be processed lawfully, fairly and in a transparent manner) as the individuals concerned would have a reasonable expectation that these particular items of personal information would not be disclosed into the public domain. Section 40 is an absolute exemption and consideration of the public interest test in disclosure is not required.

(1) The Interim People Plan, which was published by NHS England and Improvement in June 2019, highlighted that a new National NHS People Board will be established to oversee progress against the People Plan.

Please could you provide a list of all individuals currently appointed to the NHS National People Board, including their name and role on the board.

The National People Board was established in July 2019. The remit of the board was oversight of implementation of the Interim People Plan and developing the further People Plan. Members of the board were asked to join to contribute their expertise and insights. Members were drawn from NHS England & Improvement, Department of Health and Social Care, Health Education England, NHS leaders, other arms-length bodies, including clinical, operational, strategy and analytical representatives.

The National People Board was paused at the end of March 2020, in order to prioritise support to the national COVID-19 pandemic response.

A smaller National People & Workforce Strategy Group, including senior leaders across NHS England & Improvement, Department of Health and Social Care and Health Education England, was convened just to steer the development of We are the NHS - People Plan for 2020-21, published in July 2020. We are reviewing the governance arrangements for the next phase of our work.

- NHS England and Improvement Regional Director
- Health Education England Regional Director
- SROs from the STPs and ICSs within the region
- Senior posts nominated by the ICS/STP SRO
- Regional level Directors from national bodies with specific responsibilities related to People and Workforce, for example regional chief nurses
- Partners with links to the regional People Plan programme, including representatives of local government, social care, and local education providers

Review rights

If you consider that your request for information has not been properly handled or if you are otherwise dissatisfied with the outcome of your request, you may seek an internal review within NHS Improvement of the issue or the decision. A senior member of NHS Improvement's staff, who has not previously been involved with your request, will undertake that review.

If you are dissatisfied with the outcome of any internal review, you may complain to the Information Commissioner for a decision on whether your request for information has been dealt with in accordance with the FOI Act.
