- 1. On or before 19th November 2020, without lawful authority or excuse, breached licence condition 5(1) which required all areas, equipment and appliances to which the animals have access must present minimal risks of injury, illness and escape and must be constructed in materials that are robust, safe and durable, in a good state of repair and well maintained, in that:
 - a. the floor of the horse stables drained to the rear which allowed horse urine to pool under the mats and become stagnant;
 - b. the hay nets in the horse stables were tied on low rings which presented a danger to the horses' feet getting caught in the empty netting;
 - the insulation in one of the horse stables was low and had been partially eaten by one of the horses;
 - d. a leaking tap in the stable yard, which had been leaking for a considerable period, had resulted in a build-up of slime and algae;
 - e. six fences required maintenance to prevent a hazard to animals;
 - f. a metal pig trough in the pig enclosure was split along its side;
 - g. part of the pipe in the pig run was damaged;
 - h. the alpaca's enclosure was constructed using fence panels held together with wire;
 - i. WITHDRAWN

2. On or before 19th November 2020, without lawful authority or excuse, breached licence condition 5(2), which required animals must be kept at all times in an environment suitable to their species and condition, in that here was a build-up of faeces on the perches in the chicken hut.

 - a. a chopping board located in the main feed room had not been cleaned for some time;
 - b. the sink in the tack room was blocked and unclean:
 - the soap dispenser for staff to wash their hands in the tack room was not in working order;
 - d. a fly trap in the tack room was old and ought to have been removed;
 - e. an air vent in the tack room was dirty and disconnected;
 - f. the seal surrounding the upright fringe in the second feed room was dirty;
 - g. the sides, back and insides of the fridge and freezer in the second feed room was dirty;
 - a container of cat biscuits within the upright fridge in the second feed room was dirty.

Contrary to regulation 20 of the Animal Welfare (Licensing of Activities Involving Animals)(England) Regulations 2018

- 5. On or before 19th November 2020, without lawful authority or excuse,.... breached licence condition 9(9), which required prescribed medicines must be stored safely and securely to safeguard against unauthorised access, at the correct temperature, and used in accordance with the instructions of the veterinarian and condition 9(10) which required medicines other than prescribed medicines must be stored, used and disposed of in accordance with the instructions of the manufacturer or veterinarian, in that:
 - medication was stored in the upright fridge in the second feed room which was out of date;

 medication bearing an expiration date which could not be read was stored in the upright fridge in the second feed room.

Between 31st October 2020 and 19th November 2020,.... failed to comply with the requirement of Article 27, paragraph 2 and paragraph 3 of EU regulation 262/2015, in that ... failed to update the transponder and owner details for the horse known as Blue and the donkey known as Delilah with the relevant Passport Issuing Organisation.
