## Re: Information Request - Freedom of Information Act (FOIA) 2000

Thank you for your email dated 29 January 2020 requesting a review on the information that was provided to you under NIC-355225-Q6R0P. you have requested the following information:

"Specifically, it was data on place of birth at the onset of NHS care (ie consultant unit, freestanding unit or alongside midwifery unit) and birth outcomes (obviously including mortality but any additional outcomes that are available in the dataset would be helpful).

This is the data that NICE was warned to collect by the NPEU researchers if the recommendation on place of birth were to remain valid after reconfiguration.

Could you send me the link to that data, or confirm, as we suspect, that it is not being collected."

We have considered your request and in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) I can confirm that we do hold the information that you have requested.
