Freedom of Information Act 2000: Nolan Principles

Thank you for your Freedom of Information enquiry of 15 November 2016.

You asked for the following information:

Nolan Principles for public office holders - selflessness, integrity, objectivity, accountability, openness, honesty, leadership

Please provide all information held under the FOIA by the department that confirms that the Nolan Principles are integral to how your staff are required to conduct themselves and if these principles are still in force and effect as the basis of the ethical standards expected of public office holders.

Please also confirm if they are contained within your Constitution etc.

I can confirm that HM Treasury does hold information within the scope of your request.

Public office holders are required to uphold the highest standards of propriety in the discharge of their duties. The Civil Service Code, the Ministerial Code, and the Special Adviser Code incorporate the Seven Principles of Public Life. These documents are publicly available. "In matters of propriety and correctness, high standards are essential. These issues have been addressed in the First Report of the Committee on Standards in Public Life (the Nolan Report) and the Government's response to it (see the Nolan recommendations)."

"Every member of staff at the Treasury is responsible for:

- Acting in accordance with the Civil Service Code and the letter of the law;

- Conducting themselves in accordance with the seven principles of public life set out in the first report of the Nolan Committee "Standards in Public Life". They are selflessness, integrity, objectivity, accountability, openness, honesty and leadership"
