- 1. How many individual households that in receipt of more than £1000 a week/£52000 a year in State Social Security Benefits (total from all possible state benefits such as DLA, housing benefit and tax credit)?)?
- 2. How many individual households that in receipt of more than £1500 a week/£75000 a year in State Social Security Benefits (total from all possible state benefits such as DLA, housing benefit and tax credit)?
- 3. How many individual households that in receipt of more than £500 a week/£25000 a year but below £1000 a week/ £52,000 a year, in State Social Security Benefits (total from all possible state benefits such as DLA, housing benefit and tax credit)?
- 4. What is the highest weekly/yearly benefit amount/handout that is currently received by a family in the UK? in other words, what is the highest state benefit amount/handout that is currently received by a State benefit beneficiary/claimant in the UK? can you break it down by the type of benefit (i.e. how much from each kind of state benefit?"
