Request for Review of Decision under Freedom of Information (Scotland) Act 2002

Thank you for your email dated 5 November 2018, requesting a review of your Freedom of Information (FOI) request, which was passed to me for consideration.

I acknowledge that NHS Grampian breached the statutory timescale for responding to your original FOI request and therefore uphold your review request. Unfortunately, it appears that our processes failed on this occasion and I am sorry for the delay in responding which led to your review request. This was as a result of the time taken to receive information from the service and then crucial staff, who would have been able to advise if accurate data was held, being on leave.

I am now in a position to answer the question raised in your original request as follows:

Please advise me of the number of hours anaesthetists worked as Pain Consultants in each Quarter of 2016, 2017 and 2018

Please note that NHS Grampian does not hold accurate data on the information requested. Section 17 of the Act refers – Information not held.

However, we can provide some summary data on hours worked based on the number of consultant job planned clinical sessions for pain over a 48 week period – 12 weeks per quarter and 4 hours per clinical session:
