Dear Mr Kellard

Thank you for your enquiry of 18 June where you have requested information on the number of used Certificates of Sponsorship (CoS) for Tier 2 Intra-Company Transfers (ICT) with a basic salary, excluding allowances, of less than the national minimum wage, from January to May 2011. Your request has been dealt with under the Freedom of Information Act 2000.

Please see the requested information below.

The figures provided are based on both assigned and used CoS. Assigned CoS refers to CoS which the sponsor has allocated to a migrant but which have not been used as part of an application for leave to enter or remain. Used CoS refers to CoS which the migrant has submitted with an application for leave to enter or remain. Therefore, the monthly figures for assigned and used may differ. The figures are rounded to the nearest 5.
