Freedom of Information Request

Thank you for your e-mail of 25 October requesting information under the terms of the Freedom of Information Act 2000 (FOIA).

Further to your previous request (Ref: FOIR6305), you asked:

I want to know how many vehicles were DETECTED as being on the road and untaxed in the Postcode BT27 4LL and surrounding area of Lisburn [in August], whether it be by ANPR, police, or your own detection vans. NOT how many enforcement letters were issued in that area.

The Agency's wheel clamping contractors, NSL Ltd, did not clamp any untaxed vehicles in the Post Code area BT27 during the month of August 2017.

Information about the number of untaxed vehicles detected by ANPR vans in the Post code BT27 4LL is not readily available and would require a manual interrogation of each Northern Ireland case to determine the place of the offence.

Even though this information is held the Agency estimates that the cost of providing it would exceed £600. Under Section 12 of the FOI Act, DVLA is not obliged to comply with a request where the estimated cost of determining, locating, retrieving and/or extracting the information exceeds £600. As it is the DVLA's policy not to respond to requests for information that would exceed the appropriate cost limit, I am afraid that the information you have requested will not be provided to you.

DVLA does not hold information relating to untaxed vehicles detected using police ANPR systems.

The information which follows concerns the procedures for making any complaint you might have about the reply. Please quote the reference number of this letter in any future communications about it.
