Dear Sir/Madam,

I am writing about your email of 27 June 2022, requesting the following information:

**'Dear Ministry of Defence, I would appreciate a copy of any operating and maintenance manuals for the Onan Cummins 3.5kva, 120/240v ac single phase generator. The equipment plate is marked 305CCK-53CRV/3490G, Serial number 25C798658. Also general data 305CCK/314)'**

You later clarified your request on 13 July 2022 to confirm:

**'Thank you for your response. The generator referred to in Annex A is the equipment I am interested in and would therefore be grateful for any information you can provide regarding it.'**

Your request has been handled in accordance with the Freedom of Information (FOI) Act 2000.

A search has been carried out of Ministry of Defence (MOD) records and unfortunately we cannot locate any operating or maintenance manuals for the Onan Cummins 3.5kva, 120/240v ac single phase generator.

Under Section 16 of the Act (Advice and Assistance) of the FOI Act, I can advise you that our clarification letter of 8 July provided all of the general data that is held by the MOD on Onan Cummins generators; this was derived from a compendium of general purpose mobile generating sets.
