One Voice Wales proposed Welsh Government Performance Indicators for 2017-18

Quarter Three feedback 1 January to 31st March 2018

1. One performance measure as an indicator of membership coverage.

One Voice Wales suggested indicator - % of local councils in membership (Population Indicator)

We currently have 601 councils in membership or 81.77% - this represents the highest membership level as an organisation. This is an increase of 8 councils on the previous quarter. This is an increase of 9 councils – largely down to Pembrokeshire Association of Local Councils agreeing to come into membership and closing down their organisation. One Voice Wales is the only representative body in Pembrokeshire now.

2. One performance measure relating to income.

One Voice Wales suggested indicator - % of estimated income received (Performance Measure: how well did we do?)

Income from membership to date is £196,685 against a projected income of £193,000. This equates to 101.91% of estimated membership income received.

3. One or two performance measures to show how OVW is effectively supporting the sector.

One Voice Wales suggested indicators:

- a) % of members councils satisfied with advice services (Performance Measure: how well did we do?)
 - 100% based on membership feedback.
- b) % of member councils satisfied with our training services? (Performance measure: how well did we do?)

From 1 January 2018 - 31 March 2018 we ran 24 training sessions and 314 member and non-member councillors were trained. This was split between 21 scheduled courses and 3 bespoke courses.

During 2017-18 we ran 161 courses and with 1853 member and non-member councillors being trained.

4. One or two performance measures to show how OVW is representing the sector.

One Voice Wales suggested indicators:

a) No. of consultation responses made on behalf of local councils (Performance measure: how much did we do?)

During the quarter no responses have been made by One Voice Wales.

We are currently consulting on Planning Policy 10 Consultation with members as well as finalising the response to the Community and Town Council Independent Panel Review.

b) % of members satisfied with representational service? (Performance measure: how well did we do?)

Feedback from fourth quarter Area Committee's and recent 8 C&TC Review consultations suggesting very high satisfaction levels. We have had no complaints regarding this area of our work.

5. One performance measure to show how OVW is working collaboratively with partners.

One Voice Wales suggested indicator - Number of joint working arrangements in progress? (Performance measure: how much did we do?)

During last quarter taken up position on Welsh Government People and Communities Sustainable Communities Advisory Group

In February 2018 the CEO and Deputy CEO met with the Independent Remuneration Panel for Wales representing the interests of the community and town council sector. Once again a positive meeting was held with representations made being included in the final IRP report for 2018.

One Voice Wales has been invited to sit on the Understanding Welsh Places advisory board which has received funding from Welsh Government and is supported by Carnegie Trust. The Institute of Welsh Affairs will be facilitating the programme of work to begin on 17 April 2018.
