## Re: Request for Information - Freedom of Information Act 2000

I wish to confirm that the People Directorate has now completed its consideration for the information which you requested by e-mail on 31 May 2019.

Your questions and my findings are as follows:-

- How many pupils have received online tutoring at home that was paid for by the council between September 1 2017 and August 31 2018? Please indicate how many children were primary school age and how many children were secondary school age.
- 2. Please provide the same information (total number of pupils, broken down by primary/secondary) for the same period (Sept 1 Aug 31) for each of these years: 2016/17, 2015/16, 2014/15 and 2013/14.
- 3. How much was spent on providing this online tutoring? Please provide the figure in pounds for each of the school years listed above (2013/14 2017/18), broken down by school year.
- 4. Please provide the name(s) of the organisation(s) providing the online tutoring for home-schooled children.

The Council responded to a substantially similar request from you on 21 May 2019 and as such I apply Section 14(2) of the Freedom of Information Act 2000 to this request. The Council is not obliged to respond to a repeated request where a reasonable timeframe has not passed. Considering only 10 days had passed between the council's response to your previous request and the date of this request being submitted, I do not believe that to be reasonable and that is the basis of this decision.
