4 Update on progress from Delivery Group:

Call in

Members were referred to the hand-out on Lambeth Shield Call-in Tuesday 2nd June 2015 at 12noon (Brixton).

The first 'Call In' will be in Lambeth is schedule for Tuesday 2nd June as Trident are already on Borough and will implement the pre-enforcement element as part of their normal operations.

This will be followed by Westminster in May/June and Haringey in late July /early August 2015. The Pilot will run until March 2016.

Three points will be clearly communicated:

- A community moral message against violence,
- A credible policing message about the consequences of further violence,
- A genuine offer of help for those who want it.

The call-in will take place at 1200 on Tuesday 2nd June 2015 at Brixton Assembly Hall.

█ stated that an operational policing plan has been developed for the event on Tuesday 2nd by MPS Lambeth by using command structure: eg Gold, Silver, Silver runner etc.

51 gang members have been identified to attend the call-in, with their age ranging from 15 to 24 yrs old. Invitation letters have been sent to all nominals and a personal invitation has been delivered to parents and guardians.

Partner agencies and service providers will also be in attendance.

Risks

Risk has been measured and actions will be implemented accordingly.

Resource requirement

The Gang Violence Reduction Unit is funded by MOPAC to deliver gang call-ins through the London Crime Reduction Fund. This budget will cover the full cost of Cofely security, transport for the gang members, refreshments outlined above, local service providers to provide support to gang members before, during and after the event and any other small expenditure incurred e.g. travelling costs for speakers. The police have agreed to fund the cost of the policing operation.

Communication

█ and █ have been in dialogue to ensure that there is effective communication in place for the forthcoming call in. A Communications strategy has been developed by MOPAC. █ is the lead Lambeth communications officer. There will be no publicity before this event. FAQs have been prepared by MOPAC. Additionally press lines will be prepared for release at the discretion of the Cabinet Member dependant upon the outcome of the event.
