The Authority's Transport team sits within the Infrastructure directorate. Please note that the West of England Combined Authority is not a local authority and therefore does not have responsibility for most of the functions listed (Drainage, Civils, Structures, Street lighting, Street works etc.) as they are provided at local authority level.
