

Please be advised that in accordance with current guidance from the Information Commissioners Office it is Trust policy to only release names of staff to a certain level.

Please note any other names you may have requested, other than those provided, are below the designated level, as the Trust believes that it is reasonable to expect that we would disclose more information relating to senior employees than more junior ones.

Consultants and senior employees, have a greater level of accountability since they are responsible for major decisions and expenditure of public funds. In most cases a lot of this information is already on our website and so it would be inappropriate if we refused to disclose this information when requested through FOI.

However, it is not Trust policy to disclose the names of less senior members of staff, most of whom do not work in front facing roles, for the following reasons:-

The Trust has obligations to protect the personal information of individuals under the Data Protection Act. Therefore, there is an exemption on disclosure of information which we feel is the personal information of identifiable individuals.

The Trust believes that any detailed information of junior members of staff would be personal data as defined by Section 1(1) of the General Data Protection Regulations as it relates to an identifiable individual. Therefore, the information requested is personal data as described in section 40(2) of the Freedom of Information Act.

Section 40 is an absolute exemption and therefore, is not subject to the public interest test. Information has been withheld under this section because it identifies individuals who have an expectation of privacy and would not expect their name to be placed in the public domain just because they work for a public organisation

If you wish to take this matter further you have a right to ask for a review of our decision. In the first instance this should be addressed to The Head of Information Governance & Records Management, Information Governance Department, Ground Floor, Arrowe Park Hospital, Arrowe Park Road, Upton, Wirral, CH49 5PE.
