Thank you for submitting a request for information which we received on 21 May 2021 in relation to County Durham and Darlington NHS Foundation Trust (the Trust). Your request was in relation to organisational charts and I am providing the following information in response to your specific questions:

**Please provide me with an up to date Organisational Structure chart showing Team Managers and Service Managers and their email addresses for General Nursing, Primary Care, Mental Health, Learning Disabilities and Psychological Therapies across your Trust.**

As explained in our email to you on 27 May 2021, the Trust does not provide Primary Care or Mental Health (including Learning Disability and Psychological Therapies) services.
