For organisational context: University Hospitals Plymouth NHS Trust is the largest teaching hospital trust in the South West. We employ over 6,900 staff working in 350 different roles within the Trust. We offer a full range of general hospital services to around 450,000 people in Plymouth, North and East Cornwall and South and West Devon. These include emergency and trauma services, maternity services, paediatrics and a full range of diagnostic, medical and surgical sub-specialties.

We work within a network of other hospitals to offer a range of specialist services to a population of between 700,000 and two million depending on the type of care needed.

No – short term work shadowing placements do not require a DBS check because the placement comprises shadowing and observation only and the student accompanies a member of staff

5. What paperwork are applicants required to complete?

Application form, health declaration, parental consent form (16-18 year olds), at least one, preferably two satisfactory references.

6. Are applicants required to complete an induction?

An induction to the area is given by the host member of staff on the first day, but a confirmation letter is sent to the student, which includes general guidelines and health and safety information.
