I can see Ben's point but I think you're right, it will have to be resolved before their PEL is granted. I'd suggest that we spell that out in our response for absolute clarity.

Thanks Viv. Ben Ross did raise the question about whether it was correct to say that as issues can be resolvable via the licensing or conditions on the Public Entertainment licence, then there would be no significant impacts. He was likening it to the direction that SG gave to planning authorities re eps – that they should not be granting planning permission with suspensive conditions re bats – but rather should be resolving the matter beforehand. I said that I thought in this instance the EIA is not granting permission – and that they could still require that surveys should be done and if necessary Species Protection Plans drawn up BEFORE any granting of the Public Entertainment Licence – so by saying that there is mitigation that can be done so no EIA necessary – is not really the same situation as the planning permission scenario.

thank you for your enquiry about the proposal to hold the T in the Park music festival at Strathallan Estate. I can confirm that we are aware of the proposal.

Our role with respect to developments such as these is to provide advice to planning authorities (such as Perth and Kinross Council) and developers so that they can take nature and landscapes into account when designing new development, assessing new development proposals and in making their decisions.

We focus our involvement on proposals which could significantly affect the quality and enjoyment of Scotland's natural heritage. This means that our priorities are:

- national and major developments that require an Environmental Impact Assessment (EIA).
- developments that affect nationally or internationally protected sites: i.e. Sites of Special Scientific Interest (SSSIs), Natura sites and National Scenic Areas (NSAs).

We would also advise planning authorities about protected species where they were unsure if mitigation proposed to avoid an offence was adequate.

Many planning authorities, including Perth and Kinross Council, have their own in-house biodiversity staff to help inform decisions, but in some circumstances they may ask SNH for advice. We encourage developers to think carefully early on in a proposal to help ascertain whether any species and habitats surveys may be required to inform where, how and when development may take place. Although many species are afforded protection by law it does not mean that no development can take place. It can mean that the proposal, siting of houses, or timing of works for example, needs to be adapted to minimise the impact to wildlife or habitats.

T in the Park proposal at Strathallan Estate

The proposal to hold the T in the Park event at Strathallan would not impact on any nationally or internationally protected sites. We are aware that the site is home to a variety of wildlife, including red squirrels and osprey. We would expect Perth and Kinross Council to identify and address any natural heritage impacts relating to these species without necessarily contacting us directly. However, in this instance, we have been contacted by and provided advice to PKC (and the event organiser) in relation to osprey.

Protection of the water environment is the responsibility of SEPA, and again we would provide advice to them should it be requested. We, and indeed Perth and Kinross Council, recognise that the watercourses which run through the site will require protection, as this was also the case when the event was held at Balado – where the issue of pollution of the watercourses was a significant concern to us due to the sensitivity of Loch Leven to water quality issues.

You can see that for the Balado event an Environmental Management Plan was required for the Public Entertainment Licence http://www.pkc.gov.uk/article/8378/Licensing-Committee---20-February-2014 (see item 4). We would expect that the same would hold true for the event being held at an alternative location. The environmental management plan would be expected to cover things such as protection of the watercourses around the site. I understand that at Balado, SEPA required there to be a fenced off buffer area around all watercourses. The organiser may also require authorisation from SEPA for some aspects of the event.

As an interested party I would suggest that the Angling Club make known its concerns about the event to Perth and Kinross Council, who will then be able to ensure that these concerns are properly addressed in the Environmental Management Plan for the event, should it be given permission.

Further to our telephone discussion yesterday when I brought this to your attention.

I attach the draft advice to SG which is being put together by Helen Taylor and Andrew Stevenson.

As you can see, without mitigation, there would undoubtedly be disturbance if the current nest site were occupied. Since there are no measures licensable by SNH, this is very much a case of SNH giving advice to SG and to PKC who appear to be the licensing authority for the planning and other aspects of the event.

Andrew is currently on his way to Battleby from somewhere remote and will get an opportunity to help finalise the draft.

It is planned that the advice will be sent to SG tomorrow afternoon, and then there will be a teleconference between Andrew, Helen, a PKC Planner (John Williamson) and SG (Amanda Chisholm; Rosie Leven, Principal Planner; and possibly John McNairney, the Chief Planner).

I think at this stage the advice is quite straight forward in that it states that mitigation will be necessary. The discussion will give an opportunity for SG/PKC to get any clarification required and ask questions. It is possible that SG might want confirmation of the advice.

The trickier stage is likely to be deciding in due course what mitigation would be needed or if it would be acceptable. This will very much depend on local conditions around the nest. If it involves moving the nest then advice will probably be needed from osprey experts who have done this before. At some stage SNH is likely to be asked whether we think the proposals are satisfactory or not. This request is likely to come from PKC. At that stage there is also likely to be a lot of public interest.
