Re: - Internal Review of case number 17FOI246

1. Your complaint

I am writing to request an internal review of Plymouth Hospitals NHS Trust's handling of my FOI request 'Outpatient hysteroscopy/biopsy - Pain Control and Patient Choice'.

My request is part of a nationwide survey to be given to the RCOG & BSGE in an endeavour to identify and promote best practice in early diagnosis of endometrial cancer by hysteroscopy/biopsy. Over 100 NHS Trusts have replied to the request.

2. The review summary

The Trust would like to unreservedly apologise for not complying with your request within the time limits specified within section 10.- (1) of the

Freedom of Information Act 2000. In all other aspects the Trust has complied with its duties under the Act.

3. The Review

The Act states in accordance with section 1:

- (1) Any person making a request for information to a public authority is entitled—
 - (a) to be informed in writing by the public authority whether it holds information of the description specified in the request, and
 - (b) if that is the case, to have that information communicated to

and section 10:

A public authority must comply with section 1(1) promptly and in any event not later than the twentieth working day following the date of receipt.

The Trust has complied with section 1 of the Act albeit with the use of section 12 because information was only available in patient's paper based clinical records, but failed to do so within the limits specified in the Act and unreservedly apologises for the delay and inconvenience caused. A chronology has been provided as an addendum

The Trust has seen a notable increase in Freedom of Information Act requests and your case response was affected by that increased demand. Additional issues arose whilst seeking to extract data and assuring the quality of information provided.

The Trust has recently provided additional resources to assist with this increased demand and to avoid such delays. If you remain dissatisfied with the outcome of the appeal, then you have the right to appeal again to the Information Commissioner at:
