FREEDOM OF INFORMATION ACT 2000; ENVIRONMENTAL INFORMATION REGULATIONS 2004 – INFORMATION REQUEST (FOI_10-112; EIR_10-14)

I acknowledge your request for information received on 22 October 2010. Your request is being considered and you will receive the information requested within the statutory timescale of 20 working days as defined by the Freedom of Information Act 2000 (FOIA), subject to the information not being exempt or containing a reference to a third party.

There are, however, portions of this request asking for 'environmental information' as defined by the Environmental Information Regulations 2000 (EIR), and we have determined that we are not obliged to supply the information you have requested under FOIA, but rather under the EIR.

The exemption applied is section 39, exempting information that is 'environmental information' within the meaning of the Environmental Information Regulations 2004 from disclosure under the Freedom of Information Act 2000.

This exemption applies because 'environmental information' must be disclosed under the Environmental Information Regulations 2004 (EIR). In short, we will consider some of your request and provide information under EIR, not FOIA. The remainder will be considered under FOIA.

If appropriate, the information may be provided in paper copy, normal font size. If you require alternative formats, e.g. language, audio, large print, etc. then please let me know.

For your information, the FOIA and EIR define a number of exemptions (FOIA) and exceptions (EIR) which may prevent release of the information you have requested. There will be an assessment and if either an exemption or exception applies then the information will not be released. You will be informed if this is the case, including your rights of appeal.

If the information you request contains reference to a third party then they may be consulted prior to a decision being taken on whether or not to release the information to you. You will be informed if this is the case.

There may a fee payable for this information. This will be considered and you will be informed if a fee is payable. In this event the fee must be paid before the information

is processed and released. The 20 working day time limit for responses is suspended until receipt of the payment.
