Response to your Freedom of Information (FOI) request: FOI20190211

Thank you for your email of 11 February 2019. You have requested the following information under the Freedom of Information Act 2000:

A country-by-country breakdown of overseas gilt holders using the latest available figures.

The UK Debt Management Office (DMO) holds the information you have requested. By way of background, the gilt registrar, currently Computershare Investor Services plc, is responsible for maintaining, on behalf of HM Treasury, the legal register of holdings of gilts. The DMO manages HM Treasury's contract with Computershare and, therefore, holds the requested information through Computershare.

We have interpreted your request in the following way: "gilt holders" to mean the registered legal holders of UK government bonds ("gilts"); and "breakdown" to mean the total nominal amount held by the gilt holders per country.

The DMO only holds information on registered *legal* holders of gilts, not on underlying *beneficial* holders. The registered legal entity may not be the underlying beneficiary, and the beneficiary may be domiciled in a different country to the registered legal holder. Furthermore, the registered legal entity holding the gilt may be a specialist financial institution, broking intermediary, custodian or international central securities depository (CSD) acting on behalf of one or more institutional investor(s) (such as an insurance company or pension fund) or nominee company. The registered legal holder may also elect to direct the interest payments to the underlying beneficiary. This would be managed in an agreement with the holder's client and would not be apparent from the way the stock is registered.
