Dear E Lake,

Your request was received on 16 August 2017 and I am dealing with it under the terms of the Freedom of Information Act 2000 ('the Act').

You asked for:

1. Number of applications received, interview offers given, applicants pooled, direct offers made and pooled offers made for law (M100) in each college for 2015, 2016 and 2017 for first-degree domestic and overseas students respectively.

I suggest you present this in 6 tables, 2 for each year, 1 of those for domestic and 1 for overseas students. In each table, have the college be the row and applications received, interview offers given, applicants pooled, direct offers made and pooled offers for the columns.

2. Countries of origin, along with the number of students from each country, of first-degree overseas applicants who were offered a place for law (M100) in each college for 2015, 2016 and 2017.

The requested information, insofar as it is held, is attached. We do not hold information on numbers interviewed; interviews are arranged by the individual Colleges, each of which is a separate legal entity and public authority under the Act. Please note that the attached information answers both of your recent requests, the other being FOI-2017-378, and that the attached documentation should not be copied, reproduced or used except in accordance with the law of copyright.
