INFORMATION REQUEST UNDER THE FREEDOM OF INFORMATION ACT 2000

We are now pleased to respond to your request for information under the Freedom of Information Act.

You asked:

The overseas visitors amounts added for the 'impairment of receivables' rose from £20k to £46k.

.I would like to read the reasoning for the increase. (As this is an FOIA request this would Include any board papers, or internal emails).

Surely there must have been some discussion as to why the overseas visitor costs leapt from £0 to £22k? – Are board papers etc missing?

Internal email discussions of why the costs rose so much?

Was a new system instituted for instance, which allowed this increase?

And having noted this sudden increase, what has the board decided to do to ensure that the costs are paid by overseas visitors, rather than UK taxpayer?

A new Standard Operating Procedure was introduced in November 2015, please see attached. This along with an FAQ sheet, also attached, which was circulated to staff has increased awareness of this issue which has resulted in an increase.

Increased awareness has brought an increase of overseas visitor debt, as the invoice/estimate is raised immediately when non-eligible patient is identified, but this is not a guarantee that a payment will be received. The Trust has also utilised a debt agency to follow up bad debt.
