Dear Mr Clark,

Freedom of Information Request : Reference CR41692

Thank you for your e-mail of 1 November 2016, in which you ask for pages 54/55 of the Review of The Yorkshire Ripper Case by Lawrence Byford, following the Decision Notice by the Information Commissioner Office on 21 July 2016. ICO Ref: <u>FS50623441</u>. Your request has been handled as a request for information under the Freedom of Information Act 2000.

You quote an extract of the recent ICO Decision Notice – Para 49. 'The effect of this notice is that the Home Office should disclose the requested information, but with the names of living or deceased individuals whose names have not been disclosed elsewhere in the Byford Report redacted and with the sections on photofits and "Other Possible Assaults Committed by Sutcliffe" also withheld.'

The pages you now request, 54 and 55 were two of the pages that the Information Commissioner agreed should remain withheld in their entirety. The link to the ICO Decision Notice above gives you the background to this, the FOI exemptions engaged and both the Home Office and ICO reasoning.

I do however attach the document that was released by the Home Office following the Decision Notice. This document was fully compliant with the ICO's order. I hope it is useful to you.

If you are dissatisfied with this response you may request an independent internal review of our handling of your request by submitting a complaint within two months to the address below, quoting reference CR41692. If you ask for an internal review, it would be helpful if you could say why you are dissatisfied with the response.
