I refer to your recent request received on the 31 July 2019.

As per your request, please find below the information

1. How much parking is provided on James St. This is excluding any Pay & Display bays.

As per our records, there is a total of 140.7metres of parking providing in James Street which is designated for permit holders only.

As you have requested that pay and display bays should be excluded from this response, details have not been provided of the dual restriction bays. It should be noted however that as the pay and display bays located in James Street, Gillingham are a dual restriction, permit holders may also utilise these bays.

2. How many disabled bays currently are on James St.

There are currently a total of 7 disabled bays situated on James Street, Gillingham. 3 in the section of of Gillingham High Street where there is no other parking permitted and 4 within the main section of James Street where permit restrictions and dual restrictions are in force (Permit/Pay and Display).

3. How many parking permits have been issued for residents on James St. Between the dates of 01/09/18 - 01/08/18

A total of 34 resident permits have been issued for James Street, Gillingham between 01/09/2018 - 01/08/2019
