Please provide a copy of the recently-negotiated and reported parking enforcement contract between the Foundation Trust and contractors Liberty Parking Services. I understand that it relates to parking at the Northern General, the Royal Hallamshire, Weston Park hospitals and the Charles Clifford and Jessop Wing.

Please note that this company has a contract for similar enforcement activities at Bristol University and that, initially that University declined to respond to a Freedom of Information Request similar to this but they eventually did so. See

I hope that the Foundation Trust will not engage in time wasting and associated expense by resisting this request in the same way that Bristol University initially did.

Trust Response

Sheffield Teaching Hospitals NHS Foundation Trust (STHFT) sites are contracted to ISS Facilities and Excel Parking Services for controlled parking.

Liberty were identified in a separate press release made by Unison; a release that the Trust were not given any opportunity to comment on regarding its accuracy or content. It is incorrect.

Liberty are a sub-contractor to ISS Facilities. There is no contract between the Trust and Liberty t/a Car Parking Partnership. Under Section 1.1 (a) of the FOI Act the Trust has a duty to inform whether the information exists and, under Section 1.1 (b) a duty to supply that information unless exemptions apply. The information does not exist, so it can't be supplied.
