PUBLIC PATH DIVERSION ORDER

PUBLIC FOOTPATH NO. 76 AT CEFN-Y-CRIB FARM PANTYGASSEG

THIS ORDER is made by TORFAEN COUNTY BOROUGH COUNCIL ("The Authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Authority that in the interest of the public it is expedient that the lines of the paths should be diverted.

BY THIS ORDER:

- 1. The public rights of way over land situate at Cefn-y-Crib Farm, Pantygasseg shown by a bold continuous black line from A-B on the map attached to this Order and described in Part 1 of the Schedule to this Order, shall be stopped up immediately from the date of Confirmation of this Order.
- 2. There shall be at the date of Confirmation of this Order a public footpath over the land situate at Pantygasseg described in Part 2 of the Schedule to this Order and shown by a bold black dashed line from C-D on the map attached to this Order.
- 3. The rights conferred on the public under the Schedule should be subject to the limitations and conditions set out in Part 3 of the Schedule to this Order.

PART 1

Torfaen County Borough Council: Pontypool Community (now Abersychan)

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

The length of Public Footpath No.76 at Cefn-y-Crib Farm, Pantygasseg in the Community of Pontypool (now Abersychan) to be diverted commences at its junction with the private drive to Cefn-y-Crib Farm and the Blaen-y-Cwm Road (ST2425 9981) and runs in a northerly direction through a field for approximately 120 metres to a stile at the field boundary (ST2425 9994). The length of the path to be diverted is 120 metres or thereabouts and is shown on the map annexed hereto in a bold black line from A-B

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY


The length of the alternative route to replace the length of Public Footpath No. 76 to be diverted commences at a gap in the boundary wall at its junction with the Blaen-y-Cwm Road, 105 metres north west of the Farm drive's entrance (ST2918 9990). It proceeds in a north easterly direction for 70 metres along the field boundary at a width of 2.5 metres to a stile at the field's northerly corner (ST2425 9994). The length of the alternative route is 70 metres or thereabouts and is shown on the map annexed hereto by a bold dashed line from C-D.
