Please provide me with answers to the following:

1) The number, or percentage, of the GPs or nurses available and physically in attendance at the surgery at New Queen St Health Centre, Whittlesey, either on an average day or on any specific day.

I can confirm Cambridgeshire and Peterborough ICB does not hold this data. You would need to refer this request to the practice concerned. To assist I have provided a link to their website below.


