Freedom of Information Act 2000 (FOIA)

Thank you for your request, which was received on 11 March, for the following information:

"Using the DDaT framework, please provide me with the count, level, base pay scales and grade for permanent staff in post, for the below DDaT roles within HMRC.

Where an employee is recognised by a specialism, this should be rolled up into the closest DDaT job Family.

For example, for a "Java Developer" of a given capability:

4 x Senior Software Engineer, G7, £38k - £47k

2 x Principal Software Engineer, G6, £53k - £68k

This should not include non pensionable pay or allowances."

Our response

I can confirm that we hold information within the scope of your request. For each role we have provided the pay scale from National minimum to London maximum. Please note we do not hold information relating to specialist roles as they are not explicitly recorded in our Taxonomy.
