Thank you for your request dated 31 May 2018 under the Freedom of Information (Scotland) Act 2002 (FOISA) for:

Payment made by the Scottish Prison Servicd to trade unions recognised by SPS for collective bargaining broken into the following categories

The reason for each payment

The title of each payment

The name of each trade union recognised for collective bargaining

Going back 5 years

In respect to the collective bargaining process, SPS recognises the following trade unions:

- Prison Officers' Association (POA(s))
- Public and Commercial Services Union (PCS)
- Prospect

When considering the period requested, the SPS response has provided information based on financial years, i.e. April to March.

Please note that the manner in which the POA receives payment for Travel and Subsistance differs from that of the PCS and Prospect trade unions. The POA receives a capped annual amount in relation to Travel and Subsistance, the POA is then required to absorb any costs exceeding this capped amount. In contrast the PCS and Prospect trade unions are reimbursed for the actual Travel and Subsistance incurred.
