For each of the PCR systems listed above, please can you tell me the following for Ct values (all genes) in pillar 1 SARS-CoV-2 tests since pillar 1 testing began:

Mean, 10th percentile, 25th percentile, 50th percentile, 75th percentile, 90th percentile.

Also, can you tell me the percentage of positive tests by gene for each week since pillar 1 testing began? I would like if possible for this to be presented in the same way as sheet 6b of the ONS survey spreadsheet data as shown here.

Response:

The information required to respond to this request is held in individual health records, NHS Forth Valley is therefore unable to respond due to the associated costs.
