I refer to your enquiry of 12 December 2012 requesting that the undernoted information be provided to you.

"As per my right under the freedom of information act I request a copy of :

the education services' Physical Education Safety File and any procedure that relates to it. Also if the "safety file" is school specific I request a copy of the file for Ross Hall academy and the entries from March 2012 till now 11th Dec. Any names can be redacted prior to disclosure if that assists."

I can confirm that the Council holds some of the information that you are requesting. On inspecting our records, however, it would appear that Glasgow City Council does not hold all of the information which you have requested as the Physical Education Safety File, please find a copy attached, contains advice and guidance for all schools. As this file is not school specific, a file for Rosshall Academy does not exist in relation to the Physical Education safety file. Therefore Glasgow City Council, Education Services cannot supply a copy of the file for Rosshall Academy and the requested entries.
