Thank you for your request for information dated 17 November 2018, which the Council received by email. You have requested the following information:

I am looking into finding out about the location of pedestrian crossings in Tameside Council. Please could you provide me with the following:

- 1) A list of all the different pedestrian crossings within Tameside Council boundaries. Including the location of all formal crossings: Zebra, Toucan, Pegasus, Staggered Pelican/Puffin and Toucan crossings.
- 2) Information on the type of tactile paving used at each site.
- 3) A list of all lowered kerbs in the Tameside Council district. Showing the location of each and paying particular attention to the ones intended for use as pedestrian crossing points.
- 4) The above would ideally include the use of the Geocoordinate system information of each site, but also the street name and location.

The information will be used to provide a complete map of the District to aid in the navigation of Tameside Council for people with limited mobility or requiring the use of a wheelchair.

I am pleased to advise that the Council can provide some of the information you have requested.
