Thank you for your email of 26 October 2018 You made the following requests for information:

Thank you for providing those details. It is great to hear that you have moved to a better PLR system.

In your response you say that the new Cafcass PLR includes a "Self-assessment form for staff to complete to better inform assessment and support;"

1. Please provide a copy of that form

Cafcass is unable to provide a copy of the self-assessment form as it is built into the SharePoint system for each individual member of staff, it is not a separate document.

However, the attached guidance document for staff on the PLR system sets out how the self-assessment form should be completed and includes images of the form (pages 2-8).

2. Please confirm how often PLRs are undertaken for each employee: monthly, quarterly, annually etc

Please see our <u>Supervision Policy</u> which sets out the frequency for PLRs by role (section 2.0).







3. Please confirm how many PLRs have been completed since you launched the new Cafcass PLR. Ideally you would provide this data by unique employee count and preferably broken down by month.

A total of 8,201 PLRs have been completed on the new CafcassPLR site since its launch in September 2017. The below table displays the total number of PLRs completed in each month since launch.

4. Please confirm how many employees have still not had a PLR on the new Cafcass PLR since you launched it.

In Cafcass currently, there are 1,905 staff who are eligible to have had a PLR completed on CafcassPLR since its launch. Of these, 1,870 (98.2%) staff have had at least one PLR completed, and 35 (1.8%) have not had a PLR completed on CafcassPLR.

5. Please confirm that the Cafcass PLR applies to all employees within Cafcass, preferably broken down by employment or contractual relationship type, and confirm that this includes all employees up to and including members of Cafcass Board.

As stated in our <u>Supervision Policy</u>, each member of staff (employed and temporary) will have PLRs held at suitable intervals.

Cafcass Board members do not have PLRs. However, they are subject to annual appraisals by the Chair of the Board as per the terms of their appointment with Cafcass.

6. Please provide a copy of your internal HR (or other) guidance for Managers and others on how to evaluate any employee PLR and what actions to take once the PLR is complete

Please see the attached guidance document for staff on the PLR system, this includes guidance for managers.

7. Please provide an up to date copy of your disciplinary procedure

8. Please provide an up to date copy of your PLR guidance for employees

Cafcass PLR does not integrate with the Cafcass eLearning system.
