Freedom of Information Act 2000 - Request for Internal Review

Thank you for your request for a review under the Freedom of Information Act 2000 dated 16th December 2014. In line with Section 36 of the Freedom of Information Act 2000 Code of Practice (Guidance to Public Authorities etc...), we are happy to respond to your request for an Internal Review of our decision. I would also like to apologise for our late response to your request for a review.

1) Your Original Request dated 7th December 2014.

How many of the GPs working in your CCG have disclosed a holding or interest in either a standard pharmacy or a 100hr pharmacy?

What is the governance policy to prevent any conflicts of interests or abuse of position?

How many ccg board members have an interest in either a standard pharmacy or a 100hr pharmacy?

3) Your Request for an Internal Review dated 16th December 2014.

I am writing to request an internal review of NHS Bradford City Clinical Commissioning Group's handling of my FOI request 'Pharmacies owned by practising GPs'.

The information on this page is not upto date can you confirm when you intend to provide upto date information.

4) The Internal Review Process.

According to Section 36 of Section 36 of the Freedom of Information Act 2000 Code of Practice (Guidance to Public Authorities etc...), Internal Reviews must be conducted in a fair and impartial manner and should involve a fresh consideration of the information and paperwork and a thorough reexamination of the original decision and/or the handling of a request. This review should also be carried out by someone senior and unconnected with the original decision. The review must be open to the genuine possibility of an amendment or a reversal of the original decision. In order to satisfy this requirement, the original decision must be re-examined, including any and all exemptions and the results of any public interest tests which were used to decide the balance of public interest wherever a qualified exemption was applied.

5) Terms of Reference of the Internal Review

In order to satisfy the requirements of Section 36 of the aforementioned Code of Practice, NHS Bradford City CCG has called upon the services of a senior manager not employed by this CCG and who was not involved in the original decision. One additional senior manager from within NHS Bradford City CCG was also a member of the independent review.

Your request for an Internal Review queried the accuracy of the information found at the links provided in our response accompanying the use of a section 21 exemption.

6) Decision of the Internal Review

The review found that the exemption available under section 21 was correctly applied at the time as the information requested was available at the links provided. The register of interest that was displayed at the link to NHS Bradford City's website was the latest version available at the time, so it was quite correct to use the exemption and to link to this information.

NHS Bradford City CCG's Governance Manager is in the process of updating the register following staff changes and so that Clinical Speciality Leads can be included. The CCG expects this to be complete and the new registers published by the end of February or soon after.

The CCG's conflicts of interests policy has been reviewed and approved by the governing body in January 2015 in order to satisfy the new requirements published by NHS England in late December 2014.
