'Total Population' (all ages) who have received '1 dose'
'Total Population' (all ages) who have received '2 doses'
'Total Population' (all ages) who have received 'Booster or 3 doses'
Total number of COVID-19 related deaths who are 'Unvaccinated',
Total number of COVID-19 related deaths who have received '1 dose'
Total number of COVID-19 related deaths who have received '2 doses'
Total number of COVID-19 related deaths who have received 'Booster or 3 doses'**

For the avoidance of confusion, the data requested is the updated information of data provided in Table 15 of the report published on the 16th February 2022.”
