We do not hold regional or monthly level complaints data for Capita for 2015 and 2016 due to a pilot reporting system being in use at the time.

You have asked specifically for England regions and national totals, so we have removed the Scotland and Wales regional level data that we hold from these tables, although these regions are included in the provider level totals. This means the regional breakdowns do not equal the Lot totals for Lots 1 and 2. Regional figures may not sum exactly to Lot totals due to rounding.
