



Our Architectural team have now concluded their detailed assessment of floor space etc.

Before we continue with the detailed layout (understanding that we are in outline), we would advise that we are 385sqm over the 'approved by Members' scheme (July committee report) of 4,077sqm. (Neal we are now at 4,472 sqm)

The reasons for this relate to the need for the scheme to comply with Sport England Standards. In appreciating that the following may not make an awful lot of sense without you seeing a plan, we shall:

- Change the orientation of the pool;
- Show the plant on the roof (as suggested in the January 2014 Leisure Centre report) and replace the plant room with the staff room;
- Replace the staff room with the studio (again in reference to the January 2014 report);
- Deleted an unnecessary fire escape as a consequence of the above.

This changes the layout but not the model as approved by Members. It is a better layout quite frankly. We shall address this in more detail in the documentation but are we OK to continue?



I have had a phone call from Dave Sephton.

To summarise, the vegetation around the perimeter of the green is largely overgrown scrub, similar to that on Princes Parade. There are a few odd trees. The largest tree is an Evergreen Oak, the roots for this would not come to the edge of the existing vegetation.

If you need a statement from him I got this...

'No pre-development tree survey to BS 5837 is required as long as a 2m buffer is kept. Essentially none of the work required would encroach the root protection zone if this is maintained.'

There is one Ash tree that may require to be removed to created the access (this can be overcome by replacing the tree within the landscaping, and perhaps including a few extras to compensate.

The trees on the East of The Green, DS carries out the tree surveys for HTC, and in the spring, he made a recommendation to HTC for the provision of phased removal and replacement, as they are not in a good condition.

I have sent him a plan of the proposed development, and if he has any further comments following reciept of that he will get back to us.

Well, we would need full details of the other utilities on site to confirm.

We know that there is a sewer and some gas pipelines running across the site so we would need to check the exact locations of these. (We have no plans). It seems, from the information given, that there is a subterranean 'maze' of utility 'lines'.

The leisure centre as shown on our indicative site plan would need to be re-positioned ever so slightly because of a sewer (no problem) but this latest information with regard to high voltage lines could result in a very different location further to the east along the southern boundary. We would need to know what easement UK Power Networks would require and we know that the gas lines run diagonally across the site.

Show stopper? Not at this stage, but a full utility survey is recommended before any detailed design work. Otherwise, a scheme could start to run into other difficulties i.e. take up of valued play space (Sport England), impact upon neighbours and poor layout etc..

With regard to the Brown Field land issue

I have just read that the Housing Bill had its first reading today. I am still reading but draw your attention to sections 102 and 103 -

BROWNFIELD LAND

The Government will be bringing in a requirement for local authorities to hold a register of brownfield land suitable for housing through measures to be contained in the Housing Bill. The register will improve the availability and transparency of information and help to measure progress in delivering permissions against the commitment to ensure that 90% of suitable brownfield sites have planning permission for housing by 2020. Prior to the statutory requirement coming into force we would encourage authorities to set up voluntary registers.

PERMISSION IN PRINCIPLE

At Autumn Statement 2014, the Government announced that it would take action to ensure that the principle of development is established only once through the planning system. The Government built on this commitment in the Productivity Plan 2015 by announcing that it will legislate (through the Housing Bill) to grant automatic permission in principle on brownfield sites identified in the new statutory registers, subject to the approval of a limited number of technical details. Alongside this, the Government has announced it will introduce a fast-track process for establishing the principle of development for minor development proposals.

Nick's team are finalising the latest housing layout and this should be with you in the next day or two.

We know that there is a sewer and some gas pipelines running across the site so we would need to check the exact locations of these. (We have no plans). It seems, from the information given, that there is a subterranean 'maze' of utility 'lines'.

The leisure centre as shown on our indicative site plan would need to be re-positioned ever so slightly because of a sewer (no problem) but this latest information with regard to high voltage lines could result in a very different location further to the east along the southern boundary. We would need to know what easement UK Power Networks would require and we know that the gas lines run diagonally across the site.

Show stopper? Not at this stage, but a full utility survey is recommended before any detailed design work. Otherwise, a scheme could start to run into other difficulties i.e. take up of valued play space (Sport England), impact upon neighbours and poor layout etc..

BROWNFIELD LAND

The Government will be bringing in a requirement for local authorities to hold a register of brownfield land suitable for housing through measures to be contained in the Housing Bill. The register will improve the availability and transparency of information and help to measure progress in delivering permissions against the commitment to ensure that 90% of suitable brownfield sites have planning permission for housing by 2020. Prior to the statutory requirement coming into force we would encourage authorities to set up voluntary registers.

PERMISSION IN PRINCIPLE

At Autumn Statement 2014, the Government announced that it would take action to ensure that the principle of development is established only once through the planning system. The Government built on this commitment in the Productivity Plan 2015 by announcing that it will legislate (through the Housing Bill) to grant automatic permission in principle on brownfield sites identified in the new statutory registers, subject to the approval of a limited number of technical details. Alongside this, the Government has announced it will introduce a fast-track process for establishing the principle of development for minor development proposals.

Nick's team are finalising the latest housing layout and this should be with you in the next day or two.

Hi Lucy,

We have 2 main chemicals.

Sodium Hypochlorite (Chlorine) & Hydrochloric Acid.

The Chlorine is delivered as normally a 1000L pump over and stored into a tank that can accommodate that amount. This is in a bunged area to contain the liquid in the event of a leak. This delivery is normally every 7 - 9 weeks.

The Acid is delivered in 25Litre carboys and again is stored in a bunged area well away from the Chlorine. We get delivered 15 - 20 carboys at a time again about every 7 - 9 weeks.

These are all housed within the plant room which is always locked to unauthorized persons.

We also have mild cleaning solutions that are stored in a separate room in the plant room.
