(By 'Planning Committee' we mean your local authority's committee of elected members which determines planning applications. It may be known by a different name in your local authority).
- 2. Is there a limit on the number of registered speakers permitted to speak at your Planning Committee? If yes, please specify the maximum number of speakers allowed.
- 3. Is there a limit on the total time allowed for registered speakers? If yes, please provide details of the time restriction.
- 3. Are your Planning Committee procedure rules publicly available online? If yes, please provide the web link.
