Application:

I note that you have submitted comments in respect of the above planning application. I am now writing to let you know that I have received amendments to the proposal, which are summarised below:

- The application description has changed to reflect three main changes to the application, these are the removal of the 'further development plot' to the south of the site, the integration of what was previously a separate community building into the stadium itself, and a change in the proposed use of the amenity space to the east of the stadium.
- The number of units which are for food and drink uses has increased from

- three to four and a security office is now proposed. The quantity of retail floor space has not altered.
- Revised plans and documents have been received from the applicants which supersede those previously submitted, these are revisions of the Building Heights Parameters Plan, Access Plan, Illustrative Masterplan, Transport Assessment, Travel Plan, and an addendum to the Environmental Statement.
- New additional documents have been submitted, consisting of a Design Code and Land Use Parameters Plan.

Details of all internal and external consultation responses received to date are viewable online, these cover issues such as retail impact, highways and traffic, and sporting need. The plans are available for inspection at 9 St Leonard's Place, York, between 8.30am and 5.00pm on Monday to Friday. Alternatively if you have access to the internet details of the application can be viewed at http://www.york.gov.uk/planning and selecting the "View Planning Applications Online" option on the right hand side of the screen and Application Search using the reference number at the top of this letter. If you would like to make any additional comments, it is important that you do so in writing before 16 March 2012. You should not comment again if you have nothing additional to add, all previous responses will be taken into account in the determination of this application.
